## DISPLAY DETAILS AND REGULATIONS

1. Each food vendor must comply with the North Carolina Department of Environment, Health and Natural Resources and Cumberland County Health Department rules governing the operation of a temporary food stand (Section .2635).
2. Each food vendor will pay \$50.00 inspection fee to Cumberland County Health Department.
3. Each food vendor must provide U.L. approved electrical cords as needed.
4. Water will be provided at no charge, Food vendor will be responsible for providing all portable water hoses.
5. Each booth will receive 3 exhibitor passes to the Fair. (Additional badges \$20.00 each).
6. Electrical cords must be securely anchored to meet all safety regulations.
7. Sirens, bells, amplifiers, flashing lights or any equipment causing annoyance is forbidden, unless agreed to by Fair.
8. Exhibitor shall conform to all Federal, State, City and County laws and ordinances.
9. Set-up and tear-down of the Exhibit will be made during non-operating hours of Show.
10. TEMPORARY FOOD STANDS WITH SEWAGE HOLDING TANKS MUST BE PUMPED DAILY.

**IF THE ABOVE REGULATIONS ARE NOT OBSERVED, EXHIBITOR MAY BE REQUESTED TO VACATE HIS SPACE AND UNDER THESE CIRCUMSTANCES, NO REFUNDS WILL BE GIVEN.**
